POLICIES

NON-REFUNDABLE Fees

- ❖ Registration Fee(s) that cover the costs of art activities, parent information, classroom equipment, health/cleaning supplies, and overhead is due at the time of registration and is **non-refundable**.
- ❖ Tuition for May 2023 is due by May 1, 2022, and is **non-refundable**. This payment is past due on May 11, 2022 and will incur a \$10.00 late charge. If payment is not received by June 1, 2022, Epworth WCM is no longer obligated to secure a place for your child(ren) in the specified enrolled class and will retain the Registration Fee which is **non-refundable**.
- ❖ **Tuition for September 2022, is due by August 1, 2022.** This payment is past due on August 11, 2022, and will incur a \$10.00 late charge. If payment is not received by August 11, 2022, Epworth WCM is no longer obligated to secure a place for your child(ren) in the specified enrolled class and will retain the Registration Fee and the May 2023 tuition payment as they are **non-refundable**.

Late Payment and NSF Fees:

- ❖ **Tuition is due on the 1st of each month.** A \$10 late fee will be added to each tuition payment (October 2022 - April 2023) received after the 10th of each month.
- ❖ **Non-Payment Policy:** If tuition payment or fees become one month (30 days) past due, the Administration office will contact you to arrange a payment schedule. In the event no attempt is made to meet the payment arrangements, your child(ren) may be withdrawn from school and replaced with a child on an enrollment waiting list for the reserved space.
- ❖ **A \$36 fee will be added** to your account for checks returned for non-sufficient funds. If your check is reprocessed for non-sufficient funds, **a \$36* fee will be added** (*bank fee increases will be passed on to you).

Tuition

- ❖ Tuition rates: The tuition rates for the 2022-2023 school year were set based on the current economic and pandemic environment. If necessary, we reserve the right to adjust tuition beginning 1/1/23 with a 30-day notice.

Withdrawal Policy:

If it is necessary to withdraw your child(ren) from the program at any time during the school year, the Administration office must receive a **written** notice **30 days** in advance of a specific date of withdrawal. If notice is not provided, you will be responsible for payment of tuition for 30 days from date notice is provided. The Registration Fee and the May 2023 tuition are **non-refundable**.

I have received and read the school calendar and the Fee Schedule stating school begins at 9:00 a.m. each day. I understand that no credits are given for days missed due to illness or other reasons and there are no refunds or make-up days given for snow days. Epworth WCM reserves the right to cancel a class due to low enrollment and would notify you by July 31, **2022** and return all of the fees paid. I have read the above and accept my responsibility for fulfilling the financial obligations I have by enrolling my child(ren) at Epworth Weekday Children's Ministries.
